5. Preference shall be given to people who have an experience in pitching of tents. The successful bidder shall also have to work with tourism Department for promotion of Bhadarwah as a Tourist Destination.
6. Bhadarwah Dev. Authority shall identify the locations and handover the same to the lower (L1) bidder, who shall pitch the tentage at his/her own risk and cost against the license fee to be deposited with Bhadarwah Dev. Authority as given above against each.
7. Insurance/Taxes applicable under rule(or) other expenses, if any, shall be borne by allottee.

In case of any major complaint with regard to non-providing of facilities to the yatries (or) any other default as reported by any of the officer associated with yatra and if the said complaint founds correct by Chief Executive Officer, Bhadarwah Development Authority, the Earnest money deposit/security deposit shall be forfeited in total (or) in %age as per the intensity of offence.
