

In view of the deficient tenders received in this office, Bhadarwah Development Authority invites a fresh proposal from the registered production Houses, NGOs for organizing cultural shows/programmes in Bhadarwah Tourism cum Cultural Festivals 2014 scheduled to be held in the month of June 2014 along with the rate of artists (National-International) approved /unapproved by the Academy of Art Culture & Languages, Doordarshan and Radio Station Jammu & Kashmir on prescribed fee. Terms and Conditions:

- The organization should be a registered/approved production house under the Doordarshan or the registered NGO with the union Govt. /Govt of Jammu and Kashmir.
- The Organization should be well versed with the culture and heritage of Bhadarwah in particular 2. and Jammu and Kashmir State in general.
- The proposal should essentially include the folk dances of Jammu and Kashmir State (Punjabi, 3. Dogri, , Kashmiri, Bhadarwahi, Gojari, rang (Bhallessi), Paddri,) in general and erstwhile Bhadardesh in particular along with the Hindi and pop Music for power pack track based inaugural function.
- The proposal will be negotiable with regard to financial implications, which once negotiated remain 4.
- The proposal shall be evaluated on the basis of quality/ experience and as per the previous 5. standards.
- The opening and closing ceremonies shall essentially include Bhadarwahi kud with proper 6. dress of kud
- The opening of the Tourism cum Cultural Festival shall essentially include Track Based National 7. Anthem with at least 100 artists (students from vicinity) on stage.
- The committee authorized to finalize the proposal reserves the right to accept or reject the 8. proposal without assigning any reason there off .
- The payment for the approved and un-approved artists shall be purely on cultural 9. Academy/Doordarshan approved rates.
- Arrangement for transportation of equipment and artists shall purely be made by the proposer. 10.
- Full payment shall be made after completion of the event, however a mobilization advance up to 11. 25% of the finalized proposal if required shall be considered.

- 13. Laser lights, fog gun along with the decorative illumination of the venue shall form essential part of event.
- 14. Taxes as admissible under rule shall be paid by the proposer.
- 15. The proposer shall submit fifty edited copies (DVD) of the videography of all the events along with original.
- 16. There should be no repetition of the power pack items which have already been displayed during the previous festival.

The proposal should reach in the office of the Chief Executive officer Bhadarwah Development Authority on or before 7th of June 2014 up to 1 p.m. along with processing fee of Rs. 10,000/- (Rupees Ten thousand only) through bank draft/cash which may be deposited in the office of the u/s and shall be opened on the same day at 2 pm.
